

Hashlovers TURBO - General Terms and Conditions

§1. General statements

1. These Rules, hereinafter referred to as the "Regulations", define the rules for the provision of services delivered electronically, involving the rendering of services through the application Hashlovers TUBO, available on the following website: <http://hashlovers.com/>
2. The provider of services delivered electronically in accordance with the provisions of these Regulations, hereinafter referred to as "Service Provider" is: Eura7 sp. z.o.o NIP 6762429093, KRS 0000365066, REGON: 121342416, based in Kraków, os. 2 Pułku Lotniczego 47A, 31-870 Kraków, Poland.

§2. Definitions

1. Application - software made available by the Service Provider on: <http://hashlovers.com/> website as a service SaaS (called: Software as a Service), with which the user can monitor in real time service Instagram.com.
2. Instagram.com - photographic social media platform that allows photo hosting, combined with application of the same name, which enables users to take and edit pictures with the use of digital filters and share them among different social networks. The owner of the site is Facebook, Inc.. based in Palo Alto.
3. Account - created by the Service Provider in connection with the Subscription User, authorizing him to use the services of Application.
4. Account on Instagram.com - account (or profile) on Instagram.com, belonging to the User or to which the user has access data.
5. Registration - the act of filling the registration form: administration e-mail address and password to setting up an account in the Application.
6. Services - benefits received by the User - providing the tools available in the application.
7. User - a person who has registered in the Application.

§3. Regulations

1. Before using the application, the User is obliged to accept the following Regulations. The User represents that has read, understood and accepted it unreservedly and unconditionally agrees to comply with these Regulations.

2. Service Provider reserves the right to change the Terms and Conditions. New content of the Regulations shall enter into force on the date of acceptance by the User, benefiting from the Service's new content.
3. Any changes to the Regulations of the Service Provider will be notified to the User on the main page of Application.

§4. Application terms of use

1. Use of the Services is free of charge.
2. Use of the Services requires Registration - an active e-mail address is necessary.
3. Using the Services requires combining application with User's account on Instagram.com
4. While using the Application, the User must observe the rules and refrains from any action that could interfere with the functioning of the Application.
5. Service Provider reserves the right to temporarily or permanently disable User access to the Application when is being used in a manner inconsistent with Regulations.

§5. Exclusion of liability

1. The Service Provider reserves the right to temporary limitation of use of the Application and Services, due to the necessity to take measures of a technical nature, relating to software or hardware such as update, maintenance, inspection, exchange.
2. The Service Provider is not responsible for incorrect operation of the service Instagram.com

§6. Final statements

1. These Regulations are governed by the Republic of Poland and its law.
2. In matters not regulated by these Regulations, polish law acts, mainly rules of the Civil Code, the Law on electronic services and Act copyright law. (available in English on User's request)
